General Event Policy: Event rates are based on a group of 20 participants.

A participant who wishes to cancel a reservation for an event must notify the trip leader or the event coordinator immediately in writing. Reservations are not transferable by participants and The MDSC must make all changes. The trip leader or event coordinator will attempt to locate a replacement from a waiting list or by other means within his or her discretion. I also understand cancellation fees will be as shown:

- Cancellation **before** 4/25/2025 - Full Refund
- Cancellation fee **on** 4/26/25 thru 5/1/25- \$100.00
- No refunds available if cancellation **after** 5/01/2025
